

Elizabeth Knowles '12 Returns to San Diego as Director of ABA Immigration Project



Elizabeth Knowles '12 has made a triumphant homecoming to San Diego after spending nearly six months in a litigation-intensive associate position at a Seattle immigration law firm.

"I am thrilled to return as the new Director of the ABA Immigration Justice Project (IJP), a public interest organization that I care very much about," Knowles said.

She began working at the ABA Immigration Justice Project during her second year of law school as a legal intern and was later hired on as their Legal Orientation paralegal during her 3L year.

"The IJP provided me with a challenging, human-focused legal experience," said Knowles. "It required collaboration with other

community organizations and exposed me to the exciting and ever-changing landscape of immigration law, specifically in the detention context. This is where my passion for immigration law and serving detained, indigent non-citizens truly took shape. My work at the IJP as a law student served as the subject of my research and writing for the Law Review and later informed my practice as a member of the private bar."

The IJP is the only legal services provider in San Diego County that provides Legal Orientation Programs to all immigrants in removal (deportation) proceedings.

"Our legal staff presents in-depth explanations of people's rights and remedies to groups of men and women at the immigration detention facility in Otay Mesa and Immigration Court in downtown San Diego," Knowles said. "Additionally, the IJP pairs indigent immigrants with pro bono counsel for direct representation at the Immigration Court, Board of Immigration Appeals, and the Ninth Circuit Court of Appeals. We coordinate various training sessions throughout the year, including the Model Hearing Program, which is led by local Immigration Judges. The IJP's third and newest component is its Mental Health Program which focuses on identifying and providing assistance for detained immigrants who suffer from mental illness."

One of the best things about Knowles' new position is being back in San Diego again.

"I feel very fortunate to serve as director of this instrumental, ground-breaking organization and I'm thrilled to be part of the San Diego legal community again. To my delight, I have already been contacted by many of my colleagues from TJSJL who are interested in attending our trainings and taking a case on a pro bono basis. It continues to be my belief that public service is an enriching, worthwhile commitment and catalyst for personal and professional growth. Associate Dean Byrnes Selected to the Fulbright Specialist Roster

The J. William Fulbright Foreign Scholarship Board (FFSB), the U.S. Department of State's Bureau of Education and Cultural Affairs (ECA) and the Council for International Exchange of Scholars (CIES), has selected Thomas Jefferson School of Law Associate Dean William Byrnes for the Fulbright Specialist Roster for the five year term of 2013-2018 for the areas of comparative law and for taxation.

"I am honored that the Fulbright Foreign Scholarship Board and the State Department Bureau of Education and Cultural Affairs found my record of publication and teaching and impact on international education strong enough to select me from its applicant pool," said Dean Byrnes. "I really owe it to the academic recommendations provided Fulbright by Professor Richard Winchester, Dean Rudy Hasl, my former Dean, John Makdisi, and my South African supervisor, Professor Alwyn DeKoker. These recommendations play a significant role for the Review Committee in its decision making process."

"I think that my selection for this five year term, and Professor Winchester's selection two years past as a Fulbright Scholar to Tunisia, provides testament that our national peers perceive TJSL as an institution of high quality. I knew that I would be competing with candidates from large universities, but felt that it was worth the effort because of my particular impact on distance education the past 18 years and my international comparative background.

"Professor Winchester was the catalyst alerting me to the Fulbright opportunity. The rigorous Fulbright competitive process requires several levels of vetting of candidates' academic publishing record, teaching experiences, and impact on international education. To make it through the first round, a candidate must receive positive recommendations from the Fulbright Specialist Review Committee. The second round includes the Committee determining by consensus who are best qualified to be Fulbright Specialists. The Fulbright Specialist Program Council then vets the Committee's names against exclusion lists for government funds and exchanges. Finally, the names are forwarded to the Fulbright Foreign Scholarship Board for the final selection process for its specialist list.

"My goal for this opportunity is to spend time this coming academic year fleshing out some ideas regarding contextual comparative law learning that includes a social linguistic component that Professor Tiefenbrun will find familiar from her work, such as on Semiotics. I don't know where this line of thought will lead, but at least it's a distraction from deciphering tax regulations."

More on Dean Byrnes: William Byrnes is the Associate Dean for Graduate & Distance Education Programs. He pioneered online legal education in 1995, thereafter creating the first online LL.M. offered by an ABA accredited law school. He is a key founding member of the Work Group for Distance Education in Legal Education that in 2013 published "Distance Learning in Legal Education: A Summary of Delivery Models, Regulatory Issues and Recommended Practices". He has lectured courses in more than 30 countries.

Dean Byrnes has achieved authoritative prominence with 24 books, 73 book supplements, 22 book chapters, approximately 1,000 published articles, and 2 paid-subscription newsletters (e.g. Tax Facts Intelligence). His publishers include Lexis-Nexis, Wolters Kluwer, Thomson-Reuters, and National Underwriters. He is admitted to the National Press Club for the tax & insurance industry beat.







The Committee on Animals and the Law of the New York State Bar Association is very pleased to announce the Fifth Annual Student Writing Competition. The deadline for submission is July 1, 2013.


The Committee on Animals and the Law was established to provide information resources for the New York State Bar Association's members and the public about non-human, animal-related humane issues, which arise from and have an effect upon our legal system. This competition seeks to foster legal scholarship among law students in the area of animals and the law. This competition provides law students with an incentive and opportunity to learn more about this area of law.

Law students (which include J.D., L.L.M., Ph.D., and S.J.D. candidates) are invited to submit to the Committee on Animals and the Law an article concerning any area of Animal Law. All submissions will be reviewed by a panel of attorneys and other professionals practicing or otherwise involved in animal law. The winner will be chosen in accordance with the rules. The first place winner will receive \$1,000 and a certificate of achievement. The second place winner will receive \$500 and a certificate of achievement.

TOPIC	Any topic on Animal Law.
ELIGIBILITY	To be eligible for consideration, the submission must be written by a student currently enrolled (full-time or part-time) in an ABA-accredited law school. Students expecting to receive their degree in 2013 are eligible for consideration. The submission must be written by one and only one student, i.e. papers jointly written by more than one student or that have been subjected to line editing by professors or advisors shall not be considered. No paper that has been previously published in any form shall be considered. We will only accept one submission per entrant.
DEADLINE	Papers must be postmarked no later than July 1, 2013.
AWARD CRITERIA	Written submissions will be judged based on quality, clarity, originality and organization. All essays must also meet the following criteria: LENGTH: Type written, double spaced, no less than 12 point Times New Roman font, on 8.5" x 11" paper, with 1 inch margins, and no more than 25 pages, including footnotes. Footnotes should be single spaced and no less than 10 point font. FORMAT: One hard copy of the written submission and one electronic copy in Microsoft Word format on a disk or CD must be submitted by mail, postmarked no later than July 1, 2013, and addressed to:

THE CHALLENGES OF INTERNATIONAL CRIMINAL JUSTICE

Tuesday, July 16, 2013 5:30 PM – 7:00 PM Room 227



Professor Linda Keller will draw on her experience as a Visiting Professional at the International Criminal Court (ICC) to explore some of the key challenges facing international criminal justice. Using the current cases against top officials in Kenya as an example, she will discuss issues including definitions of international crimes, state cooperation, protection of witnesses, and prosecutorial discretion or alleged misconduct. The Kenya cases represent the first use of the ICC prosecutor's power to open a case on his own initiative. They are currently at the beginning of the trial stage, after charges of crimes against humanity have been confirmed against four accused. The companion cases have given rise to disputes over admissibility, with Kenya seeking jurisdiction over the cases and, failing that, seeking Security Council intervention. Controversy has arisen over the selection of defendants, adequacy of evidence, credibility of witnesses, and interpretation of crimes against humanity committed by non-state actors. The recently elected President and Deputy President of Kenya are defendants in these cases, accused of complicity in crimes against humanity while on opposing sides in post-election violence from the 2007 elections. As a result, it is likely that the upcoming trials - assuming they go forward - will continue to raise high-profile controversies.

The United States Court of Federal Claims Bar Association conducts an annual Law Student Writing Competition. The goal of this competition is to encourage law student scholarship on current topics that fall within the jurisprudence of the United States Court of Federal Claims. The winning entry in the competition will receive a \$2,000 cash prize and an opportunity to be published via the Association's website.

The cases before the court are diverse and involve a variety of statutes. They include claims arising from tax refunds, government contracts, Fifth Amendment takings (which can implicate environmental and natural resource issues), Federal procurement "bid-protests," Federal civilian and military personnel matters, intellectual property disputes, Native American tribal rights, and the federal Vaccine Injury Compensation Program.

Entries to the contest may address any topic that lies within the procedure, substance, or scope of the jurisdiction of the United States Court of Federal Claims.

Entry deadline for the 2012-13 academic year is July 26, 2013.


