**Excitement is building for the 2012 National Sports Law Negotiation Competition and Sports Law Symposium that will be held at Thomas Jefferson School of Law the weekend of September 28 – 30.** This marks the second year of this prestigious competition that features teams from top law schools across the nation.

The success and rapidly spreading reputation of the inaugural competition in 2011 has resulted in twice the number of participating teams for 2012. This year, 80 students will comprise 40 teams representing 28 different law schools, including Harvard, Notre Dame and UC-Berkeley. They will compete by negotiating real sports law issues in an academic setting.

## **Professor Tiefenbrun Presents at NAFTAZ Conference**

TJSL Professor Susan Tiefenbrun was invited by the President of the National Association of Free Trade Zones Board (NAFTZ) to be a speaker and panelist at their 40th Annual Conference and Exposition, which took place this year in San Diego at the Paradise Point Resort.

"This is a great honor for me," said Professor Tiefenbrun. "There were only four speakers on this panel, and I was chosen among many possible people who are experts in the field of free trade zones."

In addition, she distributed brochures of her new book *Tax Free Trade Zones of the World and in the United States* (Edward Elgar Press, 2012.)

More than 400 people attended the event, all of whom are involved with free trade zones in the U.S. and in the world.



**Professor K.J. Greene will be a guest speaker at the *Loyola of Los Angeles International and Comparative Law Review* and the *Loyola of Los Angeles Entertainment Law Review* symposium at Loyola Law School in Los Angeles on Friday, September 21.** The symposium is called “The New Battleground in International Intellectual Property Protection: ACTA, SOPA, TPP and Beyond.”

How do we fight international IP piracy in the digital age? The purpose of the symposium is to examine the current state of global intellectual property treaties and legislation, with a special emphasis on the drafting and negotiation of the Anti-Counterfeiting Trade Agreement (ACTA) and Trans-Pacific Partnership (TPP.) This symposium seeks to bring together interested parties to the ACTA and TPP debates and examine the possible constitutional and criminal ramifications of this legislation, as well as how content producers and rights holders can use these treaties along with existing legal frameworks to protect their intellectual property in the future.

“I will be juxtaposing the 99-percent Occupy Movement with overreaching IP legislation and trade deals in my talk at Loyola,” says Professor Greene. “What I’d like to do is point out how in IP we have the one-percent--Warner, Viacom, Disney, Sony and company driving legislation that adversely impacts the 99 percent--artists and creators. This has been true for some time, but 99 percent movement highlights the rigged system in seemingly neutral and logical IP world. Social justice perspectives--long derided as ‘political’ by traditional IP scholars --have increased potency in pointing the way to reforms that promote a more artist-centered IP regime.”

Professor Greene’s panel, “Framing the Debate – “TRIPS Plus” – Ratcheting Up Enforcement,” also features speakers from leading media institutions and government officials. For More information on the symposium visit: <http://events.lls.edu/eilr/>.



## **Professor Dyson to Present at University of Missouri-Kansas City**

Professor Maurice Dyson has been invited to speak at the University of **Missouri-Kansas City Law School** regarding **First Amendment rights in public education on Friday, September 21.**

The UMKC symposium is titled “40 Years of Landmark School Speech Cases Through the Eyes of Those Who Were There.”

Professor Dyson’s presentation is titled “Free Speech Rights in Schools: Implications in the Aftermath of *Fraser*.” He will examine constitutional free speech in public education under the *Bethel School District v. Fraser* case and how recent cases, regulation and zero tolerance policies have taken an expansive view of what is regarded as offensive speech and conduct that exceeds the scope of legitimate constitutional concern in minimizing substantial disruption to the educational process. He will be presenting along with the original plaintiffs and litigators in this landmark U.S. Supreme Court case.

In the case, Matt Fraser sued his school for disciplining him after he delivered an offensive speech at a school assembly. The Court held that school officials do not violate the First Amendment when they discipline offensive student speech.

**San Diego Law Professor to Recount Work  
in Birthplace of Arab Spring**

Professor Richard Winchester, will give a public lecture on **Tuesday, September 18**, to recount his 7-month assignment working in Tunisia, the country that gave birth to the Arab Spring.

Professor Winchester spent the first half of 2012 teaching a course called Financing International Trade at the University of Carthage as a U.S. Fulbright Scholar. His assignment began one year after the country's longtime dictator fled to Saudi Arabia following a revolution that inspired a wave of popular uprisings throughout the Arab world.

While in Tunisia, Professor Winchester bore witness to the country's efforts to draft a new constitution following the election of a transitional government. He also saw first hand the social, economic and cultural factors that are complicating the country's ability to navigate its way through the transition.

**The event will be on Tuesday, September 18, from noon to 1 p.m. at the Thomas Jefferson School of Law in room 227 and is free and open to the public. It is hosted by the law school's International Law Society.**

"I love giving blood – it's good karma," said Diana Melkin 3L. "You're saving lives and it feels good."


There were a few people who didn't keep their appointments, so walk-up donors like Sara Leprowse 1L got to donate.

## *TJSL's Externship Program Provides Great Opportunities*

If you ask Stuart Mellman 2L how he spent his summer, he'll tell you he learned a lot about what it's like to be a lawyer – even working on a case that involved a major entertainment business figure. (We wish we could tell you her name, unfortunately, we can't. But she's huge!)

Mellman knows how valuable a summer internship can be after the first year of law school—not to mention how challenging it can be as well. He interned with Brian D. Alexander of Alexander & Associates in San Diego during the summer of 2012 and handled a wide-range of legal issues. It was a full-time, paid internship, where he did legal work and kept track of his billable hours – as lawyers do in private practice.

"I was researching and writing memos everyday to advise the lawyers how to proceed," Mellman says. "I was treated as though I was an associate." Indeed, he did a lot of the type of work associates do. "I mainly worked on estate planning & probate, including an estate in excess of five million dollars," he said. He also worked on contracts, civil litigation, motions to dismiss, complaints, answers, and made trips to the courthouse to file pleadings.

"It was challenging," Mellman says, "because I was researching a lot of legal topics not covered in the 1L year."

"This past summer I was incredibly fortunate to have Stuart as an intern. He had exceptional research and writing capabilities," said Brian Alexander, the Managing Partner of Alexander & Associates. "More importantly, I could delegate projects and after reviewing a few examples from prior matters that were substantially similar to the instant project, the intern would produce quality work product with minimal revisions, saving me time and more importantly my clients money on fees."

You know you're in the real world of lawyering when a case file crosses your desk with the name of an iconic Grammy Award-winning performer on the label. Confidentiality doesn't allow us to name the artist, but she is as big as they come in music biz, and the issue was alleged trademark infringement on a line of clothing. Mellman researched the status of the case to make a recommendation on how the case should proceed. Heady stuff. He found that by the time the firm inherited the case, the opportunity to respond had come and gone.

"It was really valuable because it was my first trademark experience," Mellman said.

Mellman also worked on a case involving a national Corporation for Public Broadcasting (PBS) show that involved licensing of T-shirt logos. He also wrote a brief concerning a research and development tax credit for a large pharmaceutical company that potentially saved hundreds of thousands of dollars.

Mellman graduated from the University of Central Florida and majored in Business Management and Entrepreneurship. He is still deciding whether he wants to eventually practice in contract, trademark, intellectual property or estate law. He certainly got a taste of all of them this summer. "It was tremendously valuable," Mellman says of his internship experience at Alexander & Associates. "It gave me insight into how tremendously valuable a law degree is."

The TJSL Externship Program that Mellman is part of is ranked fifth in the nation for 2012 based on the ratio of externships the school has placed and the number of full-time students. The program offers great opportunities for hands-on legal experience and academic credit at the same time.

Brian Alexander is completely sold on the idea of law students doing internships to prepare for their post-law school careers. "Law school, while incredibly important to learn the research, writing and advocacy skills and more importantly, develop the dedication and tools for the long hours associated with the practice of law, does not necessarily prepare you for the actual practice of law," says Alexander. "In the past, attorneys would go through an apprenticeship program before becoming licensed similar to our physicians and their residencies. It is my position that this ought to be reinstated as a prerequisite to becoming a licensed attorney. Until that time, interning at a law office or government agency prepares the law student for the real world practice of law."

Mellman will continue his internship at the firm in the spring on a part-time basis.
